out to consider &c. Soon after the grand Juries aforesaid being Impannalled Sworn and Charged as aforesaid  
return here unto Court and being severally called over appear and present to the Court to have the several Bills of Indictment  
brought against Mary Housley Rose Rydel John Coffin and Benjamin Grumble Thereupon the Grand Juries aforesaid are  
Discharged and Ordered that they be allowed five hundred pounds of tobacco in their publick service this Court to be allowed  
off in the County Charge and against the aforesaid Mary Housley Rose Rydel and John Coffin so as aforesaid Indicted It is  
Ordered that Capias ipsius Returnable here at Next Court be

as he should think necessary, to testify to the Grand Jury at this Court, on behalfe of his Lordships, against any person or
