Whereupon the said Rachael Davis together with Lewis Disharoon of Somerset County planter her Security both present herein Court in their proper persons acknowledged themselves Indebted unto his said Lordship the Right Honourable the Lord Proprietary of the province of Maryland in Thirty pounds Current money of said Province of their Body, goods or Chattels Land or Tenements Severally to be made and Seized to the Use of the Inhabitants of the County of Somerset for the time being and their Successors If it happen that the said Rachael Davis and Lewis Disharoon or any or either of them then or any or either of them their Executors or Administrators do not from time to time and at all times hereafter acquit discharge and Save harmless as well the Inhabitants of Somerset County Court for the time being as also the Inhabitants of said County of and from all such Charges and Burthens what soever for or by Reason of the Birth maintenance and bringing up of the Child aforesaid and of and all other suits Charges Troubles or demands whatsoever touching or concerning of the same &c. —

Thereupon the said Rachael Davis is Ordered to give Security for the payment of all fees or fees due on the Information aforesaid to any person or persons whatsoever Whereupon the said Lewis Disharoon present herein Court in his proper person undertook for the same Rachael Davis to pay all fees or fees due to any person or persons whatsoever on the Information aforesaid In case the said Rachael Davis doth not pay the same &c. — Ordered that Information be filed against the aforesaid John Doney and that the said John Disharoon be bound for the same &c. —
