If it happen that the said David Murray doe not pay and Satisfie unto the Sheriff of the County aforesaid for the time being, fifty shillings Current money of the province aforesaid, yearly and every Year he shall keep such Ordinary or house of Entertainment as aforesaid &c.

Likewise the same David Murray with James Martin and Samuel Hopkins his Securitys, as afo. all present here in Court in their proper person as aforesaid, acknowledged themselves Indebted unto his said Lordship the Lord Proprietary in forty pounds Current money of Maryland, of their bodies, goods or Chattels, Lands or tenements severally to be made and Levied, to the Use of his said Lordship his heirs and Successors.
