William Davis of wickatomoco in Somerset County planter being present appointed Guardian to Geo. Sharp here in Court in his proper person is of his Own Consent appointed by the same Court now here as Guardian in and Over a certain George Sharp an Orphan under the age of fourteen Years untill the said Orphan should arrive at full age for the Choosing of his Guardian &c.

And thereupon it is Ordered by the Court here that Mary Sharp mother of the aforesaid Orphan deliver up unto the aforesaid Guardian all the Estate of the said Orphan that she hath in her hands and possession both real and personal - And that the said Guardian Receive the same and Give good Security for to Comply with the Law in Relation to such Guardianships as aforesaid &c.

Whereupon the said William Davis with Thomas Gillip and Christopher Dowdle of Somerset County planters his securities all present herein Court in their proper persons acknowledged themselves Indebted unto the said George Sharp the aforesaid Orphan in three hundred pounds Curr. money of Maryland of their body, goods or Chattels Lands or tenements severally to be made and Levied to the Use of the said Orphan his heirs or assigns... If it happen that the said William Davis the said Guardian doe not Comply with the Law in Relation to such Guardianships as aforesaid and doe not deliver up unto the aforesaid Orphan all his estate (Or his Guardian) all his estate both real and personal that he shall receive into his possession peaceably and quietly when ever the same should be Legally required &c.

William Davis appointed as Guardian to Mary Sharp William Davis of Wickatomoco in Somerset County planter being present herein Court in his proper person is of his Own Consent appointed by the same Court here as Guardian in and Over a certain Mary Sharp an Orphan under the age of fourteen Years untill the said Orphan should arrive at full age for the Choosing of her Guardian &c.

And thereupon it is Ordered by the Court here that Mary Sharp mother of the aforesaid Orphan deliver up unto the said Guardian all that the Estate of the said Orphan that she hath in her hands and possession lett it be what it is or ever - And that the said Guardian Receive the same and give good security for to Comply with the Law in Relation to such Guardianships as aforesaid &c.

Whereupon the said William Davis together with Thomas Gillip of Somerset County Gent and Christopher Dowdle of the same place Schoolmaster his securities all present herein Court in their proper persons acknowledged themselves Indebted unto the said Mary Sharp the said Orphan in One hundred and forty pounds Curr. money of Maryland of their body, Goods or Chattels Lands or tenements severally to be made and Levied to the Use of the said Orphan
