Thereupon at the prayer of the aforesaid David Brown the Court here valued the afo Linnen Spinning wheel so as afo Confessed by Daniel Jones Garnisher as afo to fifteen shillings Curr. money and the afo pine Chest to ten shillings Curr. money of Maryland And the aforesaid Thirty sheaves of unbroak flax so as afo Confessed by Thomas Durum Garnisher as aforesaid is valued by the Court here Ten shillings Currant money of Maryland.

Whereupon the said David Brown prays that upon giving security according to act of assembly in such case made and provided the aforesaid Linnen Spinning wheel and pine Chest, and seven pounds Curr. money of Maryland and Thirty sheaves of unbroak flax so as aforesaid Confessed by the severall Garnishes as aforesaid as of the goods and Chattels, lights and Credits of the said William Wilcox may be Condemned in the hands of the afo. Severall Garnishes towards satisfying the said David Brown his Just Claim against the said William Wilcox as all Costs accruing by means of the Attachment aforesaid &c

Thereupon Robert Jenckins Henry of Somerset County Gentleman present herein Court in his proper person undertook for the said David Brown according to Act of assembly in such case provided that in case the said William Wilcox do at any time within a year and a day appear and make all or any part of the said David Browns Claim against him appear to be satisfied or otherwise to have been undus before the laying of this Attachment that then the said David Brown shall make Restitution unto the said William Wilcox of all or such part thereof as shall be made appear to be undus &c or that he the said Robert Jenckins Henry will ^{the same} do for him &c

Therefore it is Considered by the Court here that the afo. Linnen Spinning wheel and the afo. pine Chest so as afo. Confessed by the afo. Daniel Jones and valued by the Court as afo. be Condemned in the hands of the said Daniel Jones as of the Rights and Credits of the said William Wilcox towards satisfying unto the said David Brown as well his Just Claim against the said William Wilcox as all Costs accruing by means of the Attachment afo. and that the said David Brown have thereof Execution &c

Also It is Considered by the Court here that the afo. sum of seven pounds Curr. money of Maryland so as afo. Confessed may be Condemned in the hands of the said Thomas Covington as of the rights and Credits of the said William Wilcox towards satisfying unto the said David Brown as well his Just Claim against the said William Wilcox as all Costs accruing by means of the Attachment afo. and that the said David Brown have thereof Execution &c

Also it is Considered by the Court here that the afo. thirty sheaves of unbroak flax so as afo. Confessed by the afo. Thomas Durum and valued by the Court as afo. be Condemned in the hands of the said Thomas Durum as of the Rights and Credits of the said William Wilcox towards satisfying unto the said David Brown as well his Just Claim against the said William Wilcox as all Costs accruing by means of the Attachment afo. and that the said David Brown have thereof Execution &c

thereupon the said Daniel Jones Thomas Covington and Thomas Durum Garnishes as afo are discharged from the attachment afo
