At which Court came the ^{op} of William Whittington by Francis Allen his Attorney and the Sheriff to wit John Hardy Gent: now here returned that he had taken the ^{op} Michael Holland whose body here at this day he had ready to transfer the ^{op} William of the ^{op} plea as to him it was commanded

And theas: Michael Holland in his proper person cometh and defendeth the force and Injury whereto and saith that he cannot deny the action ^{op} of the ^{op} William Whittington nor but that he did assume upon himself in manner and form as the ^{op} William above against him hath complained and as to the damage of the same William by him by occasion of the premises in that part sustained the same Michael Holland saith and Acknowledgeth that the ^{op} William hath sustained damages by occasion of the premises beyond his costs and charges by him about his suit in that part apposed to four hundred and twenty nine pounds of tobacco and not more and because theas: William doth not this but the same allegation granted to be true pray Judgment for those damages above acknowledged together with his costs and charges ^{op} to him to be adjudged

Therefore by consent of the parties ^{op} it is considered that the ^{op} William Whittington recover against Michael Holland his Damages ^{op} to the ^{op} four hundred and twenty nine pounds of tobacco by the same William in form as acknowledged

as also:

William at his request by the Court nowhere of the absent of the parties ^{op} adjudged which certain damages in the whole amount to

pounds of tobacco for his costs and charges ^{op} to the same

pounds of tobacco with stay of execution until the

first day of March then next following and the aforesaid Michael in Mercy &c.
