

Edmond Gill. Edmond Gill an Orphan is bound out by the Court here of his own accord an apprentice according to
bound to John Kellum Act of assembly in such case made and provided unto John Kellum of Somerset County Cordwainer until he arrives
at the age of Twenty One years, he being fifteen years of age the Last day of July next during the said apprenticeship to serve
in said master the full term aforesaid during which term the said apprentice his said Master well and faithfully he shall serve his secrets
keep his Commandments Lawfully and honestly every ^{where} willingly he shall do, and in all things as a good and faith full apprentice, shall demean
himself towards his said Master and his during the term aforesaid

In consideration of which Service the said John Kellum present here in Court in his proper person, Covenanteth with the Justice
of the same Court, in Court Judicially sitting, in manner and form following, that is to say that the said John Kellum, during the term
aforesaid shall and will learn, his said apprentice the trade of a Cordwainer, and to read write and Cypher, as far as the rule of three Inclusive,
and at the Expiration of his Servitude, give him a set of Cordwainers tooles, and likewise provide for his said apprentice meat or drink
washing Lodging and Cloathing, sufficient for such an apprentice, to have and ware during the term aforesaid

Whereupon the said John Kellum is Ordered to give Security to comply ^{with} the Covenants aforesaid — Thereupon the said
John Kellum together with Jonathan Sturgis of Somerset County planter, his Security present here in Court in their proper persons, Acknowledge
themselves Indebted, unto the said Edmond Gill, in thirty pounds Current money of Maryland, of their bodies, goods, or Chattles, Lands or
tenements, severally to be made and Levied, to the use of the said Edmond Gill, his heirs and assigns, If it happen that the said John
Kellum, don't during the term aforesaid learn his said apprentice, the trade of a Cordwainer, and to read write and Cypher as far as the rule of three
Inclusive, ^{and not} and at the Expiration of his Servitude give him a set of Cordwainers tooles, and do not provide for his said apprentice meat
or drink washing Lodging and Cloathing sufficient for such an apprentice to have and ware during the term aforesaid

Ordered that Elizabeth Marvell a poor woman afflicted with a grievous Malady, and having
nothing to support her self with all be allowed four pounds Curr. money of Maryland at the Tryng of the County Levy
next November

Ordered that John White of Annapolis be allowed thirty Shillings Curr. money of Maryland
for the keeping of a certain Negro Boy three months, after the death of Goiles Dasher, which did belong to the said Goile,
which money to be raised the next Levy Court

Jack a negro Slave of Samuel Kitch of Somerset County planter, being Guilty of Running away, and
Rambling and Riding of Horses at night, on application made to this Court according to act of assembly in such provid-
ed. It is Ordered that the Sheriff of the County aforesaid, take the said Negro Jack, to the publick whipping
whipping post, and there give him thirty stripes on the bare back well laid on, until the Blood appear, and that he be
Taken. And afterwards in the same Court came the said Sher: and made return that he had whig'd the said Negro
Jack, with thirty stripes, on the bare back well laid on, until the blood did appear, at the publick whipping post &c. Hereupon
the said Negro Jack is discharged, and remanded ^{back} to his Masters Service

UPON the motion of Ed George Dashiell on behalf of his Negro woman a slave Named Beck to be tax free she being
an ancient and past her Labour. Therefore it is considered by the Court here that the aforesaid Negro Beck
be tax free for the future according to the Motion aforesaid of the aforesaid George Dashiell
