Whereupon all and singular the premises being seen and by the Court here fully understood It is Considered that the aforesaid Gabriel Connolly be quiet and goe there of without Day &c. ... Upon which it is Ordered by the Court here that the said Gabriel Connolly give security for the payment of all fees, or fees, that has or shall arise due, on the premises and Information aforesaid, to any person or persons whatsoever. Thereupon came hereto Court, a certain William Deaving of Somerset County planter, and undertook for the said Gabriel Connolly, and assumed upon himself, to pay all fees or fees, that has, or shall arise due on the premises and Information aforesaid to any person or persons whatsoever &c.

Ann Clark } Right Honourable the Lord Proprietary of the Province of Maryland held at dividing  
Breck in Somerset County the third Tuesday of June to witt the day of the same -  
month and Year One thousand seven hundred and forty before his said Lordships Justices the peace in the County aforesaid to keep assigned by the Oath of Twelve Jurors being prescuted that Ann Clark Late of Stequoy parish in the said County of Somerset spinster the ninth day of June in the year of our Lord one thousand seven hundred and forty with force and Arms &c. at the parish aforesaid in the County aforesaid one pound four shillings current money of Maryland in Gold of the Value of three hundred pounds of tobacco and twelve shillings and sixpence current money in bills of Credit of the said province of Maryland of the value of one hundred pounds of Tobacco of the goods and Chattles of a certain Hugh Rimmer then and there feloniously did steal take and bear away contrary to the peace of the said Lord proprietary that now is his good rule and government and against the form of the Act of assembly in such case thereof lately made and provided &c. By which Command is to the Sheriff of the County aforesaid that he should take the said Ann Clark if &c. to answer &c. And now to witt at a Court then held for the County aforesaid at Dividing Breck in the same County the third Tuesday of June and Year One thousand seven hundred and forty before his Lordships Justices came the aforesaid Ann Clark in her proper person according to a certain Recognizance by her and her Security in that part first acknowledged - Thereupon the said Ann Clark's appearance
