The Court being sat as above and proclamation being made in usual form the Sheriff of Somerset County to wit
John Hardy Gent. being called makes Return of a panel of Grand Jurors as follows - to wit Nicholas Fountain

William Nelson, Thomas Bellis, Whittington King, Thomas Leyley, John Goddard, William Duet, David Hudson,
Samuel Dowell, Spence Hale, John Mercy, William Mills, Samuel Davis and Edward Puffe, - the Jurors aforesaid
as and Impanned, being called by their names doe appear as above, and were sworn and charged and Seal Out
to consider &c soon after the Jurors aforesaid being sworn and charged as aforesaid Return hereinto Court, and being
severally called over did appear, and were accordingly discharged by the Court &c

George Douglas of Somerset County Gent. is appointed by the Court here to prosecute his Lordships place in
Somerset County Court, in the absence of Robert Jenkins Henry of the County Esq; Gentleman, and that he have full power
to order out all such subpoenas, as he should think proper, to testify to the Grand Jury, on behalf of his Lordships his
Court against any person or persons whatsoever &c

At the prayer of George Douglas Gent. prosecutor appointed it is ordered by the Court here that the
Sheriff of Somerset County to wit John Hardy Gent. Return a panel of Grand Jurors immediately to this Court
to inquire for his Lordship the Lord Proprietary and the body of the County of Somerset in usual manner.

Whereupon proclamation being made the same Sheriff made return of a panel of

William Mills, Samuel Davis, Edward Puffe, - And thereupon proclamation being made in common form to the Jurors
aforesaid Impanned, being severally called over by their names doe appear, as above and were sworn to enquire and charge
and sent out to consider &c soon after the Grand Jurors aforesaid being Impanned sworn and charged as aforesaid returned hereinto Court
and being severally called over aforesaid and present to the Court here the several bills of Indictment Against Jean Hains, Elizabeth Grey
Rachel Bennett, Sarah Mears, Majorant Mallard and Daniel Dennis Thereupon the Grand Jurors aforesaid are discharged
