Whereupon proclamation being made the same Sheriff made Return of a panelle of of a panelle of Grand Jurors as aforesaid he was ordered in form following to wit Nicholas Fountain, William Waters, Mutton Hill, William Venables, Joshua Sturges, Abraham Corder, William Bosman, John Gillett, William Nelson, Whittington King, Thomas Keyley, Wm Duett, John Goddard, David Hudson, Samuel Duett, Spence Hall, John Mercy, William Mills, Samuel Davis, Edward Cluff, and thereupon proclamation being made in common form &c. the Jurors aforesaid Impanelled, being severally called over by their names doe appear, as above and were sworn to enquire and charged and sent out to consider &c. soon after the Grand Jurors aforesaid being Impanelled sworn and charged as aforesaid returned hereinto Court and severally called over appeared and present to the Court here the severall bills of Indictment Against Jean Hains, Elizabeth Cary Rachel Penuel, Sarah Mears, Marjoram Mallard and Daniel Dennis Thereupon the Grand Jurors aforesaid are discharged
