James Bolk, Daniel Jones & Ishmael Davis came and were sworn upon that Jury and became the rest of the Jury
of that same Jury did not appear therefore others of those standing by serjeants elected by the Sheriff of the County aforesaid
and at the request of the aforesaid Francis Allen Esq. and by the command of the said Justices are now put on whose
names to the panel within written are affixed according to the form of the Statute in such case made and provided which
Jury so newly put on to wit Edmund Haugh Thomas Michael Isaac Costo and Edward Rownd being called Evidence -
came who to say the truth of the premises together with the other Juries aforesaid first impannelled and sworn being elect
hired and sworn upon their Oath say that the aforesaid Robert Geddes the day and year above said did not after affirm
releate say and publish the aforesaid Words in the declaration aforesaid specified as the aforesaid Francis Allen Esq. above
against him hath complained

Therefore it is considered that the aforesaid Francis Allen Esq. take nothing by his writt aforesaid but be
thereof in mercy for his false Ramon and that the aforesaid Robert Geddes goe thereoff without day &c also it is con-
sidered by the Court here that the aforesaid Robert Geddes recover against the aforesaid Francis Allen Esq. Six hundred
and Ninety eight pounds of tobacco for his Costs and Charges by him about his defense in this part Expended to the same
Robert by direction of the Justices here adjudged according to the form of the Statute thereoff made and provided her-

at the same

Command was given to the Sheriff of Somerset County that he should take Robert
Geddes late of Somerset County Inholder and Susanna his wife if they should be found
in his baileywick and them should safe keep so that he might have their bodys before the
Justices of his Lordships County Court of Somerset to be held at Bridgwater the third Tuesday of
November anno Domini one thousand seven hundred and thirty nine Amons unto Francis Allen
Junr of a plea of trespass upon the case &c and the same day is given to the aforesaid Francis Allen Esq.
At which day here came the aforesaid Francis Allen Junr by Francis Allen Esq his attorney
and the Sheriff to wit John Henry Gent now here returned that he had taken the aforesaid Robert
Geddes and Susanna his wife whose body hereat this day he had ready to answer the aforesaid Francis
Allen Junr of the aforesaid plea as to him it was commanded

And hereupon the said Robert Geddes and Susanna his wife puts in the place George
Douglas Gent attorney at Law against the aforesaid Francis Allen Junr of the aforesaid plea
Whereupon at the request of the parties aforesaid day is to them here given until next Court
to be held at Bridgwater the third Tuesday of March then next following in the same
state as at present saving to the parties aforesaid

At which day here came against the parties aforesaid by their attorneys aforesaid and hereupon the said
Francis Allen Junr complained against the aforesaid Robert Geddes and Susanna his wife in the
plea aforesaid following
