Charles County Jff. Aaron Nally late of Charles County Sheriff was attached to be sworn unto Samuel Hanson High Sheriff of Charles County Jff. of All Pleas of Trover upon the said and so forth.

And Whereas the said Samuel by some hath his attorney complains that whereas the said Aaron Nally the 10th day of May in the year past sold one thousand seven hundred and forty seven at Charles County aforesaid and indebted to the said Samuel Hanson for the same five thousand one hundred and ninety eight pounds of tobacco produce particularly lying properly in and amount as by the Particulars hereunto brought may appear and being so thereby indebted the said Aaron in consideration thereof afterwards to wit the day and year aforesaid at the County aforesaid upon himself promised to the said Samuel Hanson and there faithfully promised that he the said Aaron the said five thousand one hundred and ninety eight pounds of tobacco to the said Samuel when the unto aforesaid he should be required will and truly would content and pay Nevertheless the said Aaron Nally his promise and assumption aforesaid regarding but merely and fraudulently intending the said Samuel Hanson in this Particularity and ability to receive and defraud the said Hanson the said sum of two thousand one hundred and ninety eight pounds of tobacco or any part thereof to the said Samuel hath not paid nor has performed in any sort Contents at this the said Aaron Nally aforesaid to wit the first day of July in the year and at the County aforesaid and often since by the said Samuel hath been the unto requested but the same to him to him to, to buy or him for the same many sort to content the said Aaron Nally hath altogether refused and still doth refuse to the damage of the said Samuel Hanson five thousand three hundred and ninety eight pounds of tobacco and therefore he brings suit aforesaid
