Wth the said Alexander by Henry Darnall his attorney comes and defends before and sheweth upon and reports a rid pray appearing of the Writing obligatory afo. and it is read unto him and he also pray appearing of the condition of the Writing obligatory and it is read unto him in these Words following to wit

The condition of the above obligation, is such that if the above bounden Alexander does his Heirs &c. that and do well and truly pay unto the above mentioned Samuel Stuen his Heirs &c. Dem. 20 p. pignors or betwain Attorney the sum of one Thousand six Hundred Pounds of good Merchable Tobacco in two Hogheads to be contain the same at or before the Tenth day of December next ensuing this date hereof with Lawfull Interest thereon that then the above bond to be void and of no Effect, but if Default be made in payment of the lastment. Term of Tobacco or any Part thereof with Lawfull Interest as above said then sheweth. Inpursue any Attorney practicing in any Court of Record in the Province aforesaid the Colony of Virginia or Elsewhere in his Majesty's Dominion to appear for me at suit of Samuel Stuen and to confess Judgments either by Nisiavit by nonvit return or Nonsum Informatus sheweth releasing all Errors as may happen on such Judgments and providing this shall be the same as any Authority to be sheweth and Seal the Day and year above written

Which being read and heard the said Alexander by his attorney of P. Comes and Defends before and sheweth upon &c. and the said Attorney saith that he is not informed by the same Alexander of any answer to make for the said Alexander to the said Samuel Stuen in the Premises nor hath he any other thing to say in Bar or Preclusion of the action of the aforesaid Samuel by which the said Samuel Stuen against the said Alexander though without Defense

Therefore it is considered that the said Samuel recover against the said Alexander his Debt and his Damages by reason of detaining that Debt to two thousand and six hundred and thirty one pounds of Tobacco to the said Samuel of this Court here adjudged and the said Alexander in money &c.
