Whereupon His Commanded the Sheriff that of the Good Charles Wobles of the said County of Charles County in his County of Charles County being he should attach as well the sum of Eight Hundred and fifty five pounds of Tobacco and Spanish Current Money and the best that may arise thereon of Tobacco for goods that had arisen and that further should arise in Prosecution of the promise and when the same he has attached or any part thereof that he should have it before the Justice of the Lord Proprietary of his Nearest County Court to be held at Charles Town on the Second Tuesday in November next then and there to be condemned according to Law to and for the use of the said Samuel Hanson just unless the said Defendant should come then and there by himself or some full attorney and answer unto the said Samuel Hanson just of a plea of Trespass upon the case and that by God and Lawfull men of his County of Charles County he should make known to the Person or persons in whose hands he should make the same attachment with the name that he she or they be and appear before the Justice of the said Lord Proprietary at the place and time aforesaid to show Cause if any he she or they have any matter in their or any of their hands attached should not be condemned according to Law and the said Samuel have three of Execution, if he or she or they be should execute that Writ that he should make known to the Justice aforesaid at the time and place aforesaid and that he should have then & there that Writ and the Names of those before whom he should make the same known &c.
