 at Charles County afo: was indebted to the said Corn: Sandford with the
 sum of seven pounds seven shillings and three pence half penny
 Currency for divers articles lying for a long time in an account as by the particular
 account thereof transmitted into Court may appear and being afterwards
 indebted the afo: William in consideration thereof afterwards to wit the
 day and year afo: at the County afo: upon himself assumed and to the said
 Cornelius then and there with fully promised that he the afo: William, the afo:
 sum of seven pounds seven shillings and three pence half penny
 the said Cornelius when thereunto afterwards he should be required
 will and he would content and pay **NEVER** the less William has
 promissed and assumption afo: not regarding but minding and
 fraudulently intending the same Corn: Sandford's property & subtilly to
 deceive and defraud the afo: Wm the said sum of seven pounds seven
 shillings and three pence half penny currency or any part thereof to
 the said Corn: Sandford hath not paid nor paid for the same in any
 sort contented altho the afo: William afterwards to wit the third day
 of September in the year of our Lord one thousand seven hundred &
 forty seven and often afterwards at Charles County afo: by the said Corn:
 Sandford hath been requested but the same to him hitherto to pay or
 him for the same in any sort to content hath hitherto altogether
 refused and still doth refuse to the Damage of the said Cornelius
 Sandford fourteen pounds fourteen shillings and six pence
 Currency and therefore it is brought in as above forth
