At which day to wit the second Tuesday in March afo^{rs} comes here as well the said Thomas as the said Edward by their Attorneys afo^{rs} and the said Thomas by his said Attorney Prays further leave to impeach hereto until the next Court to be holden at Charles Town on the second Tuesday in June and he hath it and the same day is given to the same Edward here v^o

At which day to wit the second Tuesday in June afo^{rs} comes here as well the said Thomas as the said Edward by their Attorneys afo^{rs} and the said Thomas by his said Attorney Prays further leave to impeach hereto until the next Court to be holden at Charles Town on the second Tuesday in August and he hath it and the same day is given to the same Edward here v^o

At which day to wit the second Tuesday in August afo^{rs} comes here as well the said Thomas as the said Edward by their Attorneys afo^{rs} and the said Thomas by his said Attorney Prays further leave to impeach hereto until the next Court to be holden at Charles Town on the second Tuesday in November and he hath it and the same day is given to the same Edward here v^o

At which day to wit the second Tuesday in November afo^{rs} comes here as well the said Thomas as the said Edward by their Attorneys afo^{rs} and the said Edward by his said Attorney Prays further leave to impeach hereto until the next Court to be holden at Charles Town on the second Tuesday in March and he hath it and the same day is given to the same Edward here v^o

Whereupon all and singular the Petitions being by the Court here according to the Directions of the Act of Assembly in such Cases late made & provided fully seen heard and tendered and due Deliberation thereupon had It is adjudged and Decreed that the said Edward take nothing by his Bill afo^{rs} ^{admitted} but he and his Pledge of Prosecuting him Mercy v^o and the said Thomas go thereof without Day v^o It is likewise considered that the said Thomas cannot do Recovery against the said Edward for the
