

Whereupon It was commanded the Sheriff that of the good Chables He reside of the pt.
 Robert Meinar in his Bailysick being he should attach and sell the same in Thousand four
 Hundred and six Pounds of Tobacco and sixteen shillings and six pence Currency & amaze
 as Three Thousand Pounds of Tobacco for Costs that had accrued and that further should accrue
 in Prosecution of the Pleas and when these are being attached or any Part thereof that
 he should have it before the Justice of the Lord Proprietary of his Next County Court to be
 held at Charles Town on the second Tuesday in March next then and there to be
 condemned according to Law to and for the use of this said Robert Franklin unless the
 Robert Meinar should come then and there by himself or any full attorney and
 answer unto the said Robert Franklin of a plea of Trespass upon the Case and that
 by good and lawful means his Bailysick he should make known to the Person or
 Persons in whose hands he should make this same Attachment that he or they
 be and appear before the Justice of the said Lord Proprietary at the Place and time
 to show cause if any he or they have why the same in their or any of their hands
 attached should not be condemned according to Law and the said Robert Franklin
 have the use of Execution if he and how he should execute that Writ that he should
 make known to the Justice afo at the Time and Place afo and that he should
 have then and there that Writ and the Names of those before whom he should
 make the same known &c

And now here at this day to wit the second Tuesday in
 March comes the said Robert Franklin by Jeremiah Chase his attorney and offer himself
 against the said Robert Meinar in the plea afo and the Sheriff returns to the Court
