Under the hand and seal of the said William bearing date the day and year last named granted himself to be held and firmly bound to the said Cornelius Sanford his heirs Ex^{ors} Adm^{ors} or assigns in the just full sum of Twelve Thousand two Hundred pounds of good sound merchantable Leaf Tobacco in Cash to be paid unto the said Cornelius Sanford his heirs Attorney Executors Administrators or assigns at or upon the first day of January next ensuing the date hereof and the said John further saith that the said Cornelius Sanford after the twenty first day of September in the year of our Lord one Thousand Seven Hundred and forty Six in Charles County afo. by his certain Writing under the hand and seal of him the said Corn^l Sanford bearing date the day and year last mentioned according to the form and Effect of the act of Assembly in such cases made & provided, assigned the said Writing obligatory to the said John for Value Received as therein mentioned of which said assignment the said John afterwards to wit on the said twenty sixth day of February in the year last mentioned at Charles County afo. to the said W^m Shebald gave notice and the said John in fact saith that the said William altho often required the afo. sum of Twelve Thousand two Hundred pounds of Tobacco to the said John hath not paid nor any part thereof nor for the same in any sort contented but he came to him to pay hath hitherto altogether refused by Value of which assignment and of the act of Assembly Action hath arrived to the said John to have and require of the said William the afo. sum of Twelve Thousand two Hundred pounds of good sound merchantable Leaf Tobacco Leaf Tobacco in Cash afo. yet the said W^m altho often required the afo. sum of Tobacco to the said John hath not rendered or paid but he came to him to render & pay hath hitherto altogether refused and still doth refuse to the Damage of the said John Twenty Thousand p. of Tobacco and therefore he brings Suit and so forth and he brings hereinto Court as well the Writing obligatory afo. as the Writing of assignment the afo. said which the Debts and assignment thereof afo. testify the dates whereof are the several Days & years afo. said
