Judgment by Nonsum Informatus

Charles County sh: Thom as Mould late of Charles County & later otherwise
called Thomas Mould of Charles County & later was summoned to answer
unto John Wbuschell of plea that he rendered unto him the Just and full sum of
Thousand Two Hundred pounds of good sound & merchantable Sea Tobacco in fact
which to him he owes and unjustly detains and so forth

And whereupon the same John by Annisak Chase his attorney saith that
whereas the said Tho: Mould by the name of Tho: Mould of Charles County & later on the
Eleventh day of August in the year of our Lord one thousand seven hundred forty six
at Charles County sh: by his certain Writing Obligatory under the hand and seal of the said Tho:
bearing date the day and year last named granted himself to be held and firm by bond
to the said Carn: Sandford his Heirs Ex: Adm: or assigns the Just & full sum of
Twelve Thousand Two Hundred pounds of good sound & merchantable Sea Tobacco
to be paid unto the said Carn: Sandford his certain attorney Ex: Adm: or assigns at or
upon the first day of January next ensuing the date here of and the said John further saith
that the said Carn: Sandford after the twenty first day of September in the year of our Lord one
thousand seven hundred & forty four to wit the twenty seventh day of February in the
year of our Lord one thousand seven hundred & forty six at Charles County sh: by his
certain Writing under the hand and seal of him the said Carn: Sandford bearing date the
day and year last mentioned according to the form & effect of the act of assembly in such
Cases made & provided assigned the said Writing obligatory to the said John for Value
received as therein mentioned of which said assignment the said John afterwards to wit
on the said twenty seventh day of February in the year last mentioned at Charles County
sh: to the said Thomas Mould gave notice and the said John in fact saith that the said
Thomas Mould often required the aforesaid sum of Twelve Thousand Two Hundred pounds
of Tobacco to the said John hath not paid nor any part thereof for the same in any sort
