Well Remembered that hertofore to wit the second Tuesday in March Anno Domini One Thousand Seven Hun and forty four by the oath of four true Jurors Namely Robert Dade &c was presented Susanah Plummes for bearing a bastard Child And Now here at this day to wit the second Tuesday in June aforesaid the said Susanah in custody of the Sheriff Namely Samuel Harrison Gent. to the Court here brought in her proper Person comes and being demanded of her by the Court here whether she be guilty of the barter afo. above upon her Imposed, she the said Susanah says she is thereof guilty in manner and form as by the Presentment aforesaid against her it is alleged

Therefore it is considered by the Court here that the said Susanah be fined via Hundred Poundes of Lawfull Thirty Shillings current money for her offence afo. according to the force and effect of the Act of Assembly in those Cases late made and provided, and that the said Susanah be taken into Court here in his proper Person comes dwelling in the County of Blantier and becomes Pledge and Security for the said Susanah to pay the fine afo. as also other several fees arised due to the Officers and Ministers of the Court here by occasion of the Demerits

Well Remembered that hertofore to wit the second Tuesday in November last by the oath of four true Jurors Namely &c was presented Elizabeth Morris for bearing a bastard Child And Now here at this day to wit the second Tuesday in June afo. the said Elizabeth in custody of the Sheriff Namely Samuel Harrison Gent. to the Court here brought in her proper Person comes and being demanded of her by the Court here whether she be guilty of the barter afo. above upon her Imposed, she the said Elizabeth says she is thereof guilty in manner and form as by the Presentment aforesaid against her it is alleged

Therefore it is considered that the said Elizabeth be fined or suffer corporal Punishment according to the directions of the Act of Assembly in those Cases late made and provided, and also that the said Elizabeth cannot lay or procure any Person to be Security for the fine afo. by the Act afo. imposed Moreover the Sheriff that he take her to the whipping Post and having stripped her Naked from the Waist upwards he give her ^{ten} lashes on the bare back for the offence afo. And afterwards to wit the same second Tuesday in June aforesaid the Sheriff returns to the Court here that he hath done Execution of this said Judgment upon the afo. Elizabeth Whereupon into Court here in his proper Person comes James Nicolson of Charles County Merchant and becomes Pledge and Security for the said Elizabeth to pay the several fees arised due to the Officers and Ministers of the Court here by occasion of the Demerits

Whereupon it is by the Court here further considered that the said Elizabeth Morris do make her Master James Nicolson Injoyan Satisfaction of the ^{said} fine and trouble of his house and the fees arised due to the Officers and Ministers of the Court
