Charles County vs James Eaton late of Charles County Planter was attached to answer unto Sam<sup>l</sup>  
 Hanson Esq<sup>r</sup> High Sheriff of Charles County of plea of Trespass upon the Case and so forth  
 And whereupon the same Samuel by Jeremiah Chase his attorney complains that whereas the  
 James Eaton the fourth day of April in the year of our Lord one thousand seven hundred & forty eight  
 at Charles County vs was indebted to the said Samuel in the sum of one thousand & fifty six  
 (Pounds)
