Sounds of Tobacco for divers Articles lying Properly in an Account as by the Particular Account thereof here with into Court brought may appear and being so thereof indebted the said James Eaton in consideration thereof afterwards to wit the day and year aforesaid at the County of ... Upon himself assumed and to the said Samuel then and there faithfully promised that he the said James the said sum of one thousand and fifty six pounds of Tobacco to the said Samuel when thereunto afterwards he should be requested and fully would content and pay. Nevertheless the said James his Promise and assumption not regarding but minding a not fraudulently intending the same Samuel in this Part craftily and subtly to receive and depaude the said James the said sum of one thousand and fifty six pounds of Tobacco or any part thereof to the same Samuel he the not paid nor him for the same in any sort Contented altho the said James afterwards to wit the 15th day of December in the year of our Lord one thousand seven hundred and forty eight or soon afterwards at Charles County aforesaid by the same Samuel hath been requested but the same to him hitherto to pay or him for the same in any sort to Content hath hitherto altogether refused and still doth refuse to the damage of the same Samuel the said one thousand and fifty six pounds of Tobacco and therefore suit is brought to the Court
