Charles County vs. Richard Roby late of Charles County Planter was Attached to an account as follows: Robert Scott and John Howard by Jeremiah Chase their attorney Complain that whereas the said Richard Roby the Twenty Third day of December in the year of our Lord one thousand seven hundred and forty seven at Charles County afo. was indebted to the said Robert Scott and John Howard Nine Hundred and Eight Pounds of Tobacco for such articles as by Populyn an act as by the Particular Account hereof here with into Court brought may appear and the said Richard Roby being so lawfully cited in consideration thereof afterwards to wit the day and year afo. at the County afo. upon his self assumed and to the said Robert Scott and John Howard then and there faith fully promised that he the said Richard Roby the said sum of one thousand seven hundred and eight Pounds of Tobacco to the said Robert and John when thereunto afterwards he should be requested well and truly would content and pay Nevertheless the said Richard Roby his promise and assumption afo. not in the least regarding but mind and fraudulently intending the said Robert Scott and John Howard in this matter craftily and subtilly to deceive and defraud the said sum of one thousand seven hundred and eight Pounds of Tobacco or any part thereof to them the said Robert and John or either of them hath not paid or contented with the said Richard Roby was afterwards to wit on the first day of June in the year of our Lord one thousand seven hundred and forty eight and often since at the County afo. by the said Robert and John thereto requested but the same to them or either of them hitherto, to pay or for the same in any sort to content the said Richard Roby hath in that behalf refused and still with refuse to the damage of the said Robert Scott and John Howard Nine Hundred Eight Pounds and Eighteen Pounds of Tobacco and thus he they bring in and of forth the
