Samuel ought not to have his Execution against him for his Damages & Costs afo. according to the form force & Effect of the Recovery afo. if it shall seem Expedient to him and further to do and receive all and singular those things which the same our Court shall thereunto direct and Order of them in this Particular and have them and these the Names of those by whom thou shalt make him to know and this the 14th of April now here at this day to wit the second Tuesday in March aforesaid Comes the said Samuel by his attorney afo. and offers himself against the said John Burch in the Plea aforesaid and Samuel Gunn one of the Coroners of Returns to the Court here the Writ aforesaid thus Indorsed Viz

And the said John Burch in his proper person into Court here comes & nothing in Part or Reformation of the Execution afo. do they say contrary to the said Samuel remains against him undefended. Therefore it is considered by the Court here that the said Samuel have his Execution against the said John Burch of the Damages & Costs afo. according to the form of the Recovery afo. It is further considered that the said Samuel do recover against John Burch the sum of One thousand seven hundred and some half Pounds of Pounds for his Costs and Charges by him in Prosecution of the said afo. laid out and Expended to the same Samuel at his Request by the Court here adjudged according to the form force and Effect of the Statute in such Law made and Provided and that the same Samuel have thereof Etc. &c.
