Charles County sh. John Hatcher late of Charles County by mes was attached to answer unto Daniel Stephan & Com of a piece of Trespass upon the Case and so forth.

And Whereupon the same Daniel & Company by Jeremiah Chase their attorney Complain that whereas the said John the Seventh day of May In the year of our Lord One Thousand Seven Hundred and forty Eight at Charles County sh. was indebted to the said Daniel and Company in the sum of Two Thousand five Hundred and Ninety eight Pounds of Tobacco for divers Articles lying Properly in an account as by the Particular account thereof here with into Court brought may appear and being so the said Indebted the said John in consideration thereof afterwards to wit the day and year afo. at the County afo. said & upon himself assumed and to the said Daniel & Company then & there faithfully promised that he the said John the said sum of Two Thousand five Hundred and Ninety eight Pounds of Tobacco to the said Daniel & Company when there unto afterwards he should be requested well and truly would Content and Pay, Nevertheless the said John his Promise and Assumption afo. not regarding but minding and fraudulently intending the same Dan. & Company in this Part craftily and subtilly to deceive and defraud the said Dan. & Company of Two Thousand five Hundred and Ninety eight Pounds of Tobacco or any Part thereof to the same Daniel & Company hath not paid nor them for the same in any sort Contented altho the said afterwards to wit the fourth day of October In the year of our Lord One Thousand Seven Hundred & forty Eight and often afterwards at Charles County sh. by the same Daniel & Com hath been requested but the same to them hither to to Pay or them for the same in any sort to Content hath hither to altogether refused and still doth refuse to the Damage of them the same Daniel & Com Five Thousand One Hundred and Ninety six Pounds of Tobacco and therefore suit is brought as forth
