 Whereupon the said Daniel & Company by their Attorney afo<sup>r</sup> Prays Judgment and those Damages so acknowledged together with his Costs and Charges by him about his Suit in this part laid out and Expended to them to be adjudg'd — Therefore it is considered by the Court here that the said Daniel & Company do recover against the said John their Damages afo<sup>r</sup> to Two Thousand five Hundred and Ninety Eight Pounds of Tobacco as well as the sum of Two Hundred Eighty Seven Pounds and Three Quarters of a pound of Tobacco for his Costs and Charges by him about his Suit in this part laid out and Expended Defin'd on his Assent by the Court here adjudg'd and the said John in Mercy He<sup>r</sup> —
