Jointly and severally in and for the whole firmly by these Presents sealed with our seals and dated this 11th day of June in the Thirtieth year of the Dominion of the Right Honourable the Lord Proprietary that now is &c. Anno Domini 1759

Whereas Robert Gates Junr. Administrator of Ann Nyeths hath this day Deliv^d. unto William Bryan the sum of sixteen Pounds Ten Shillings and six pence Current Money the Kallanessie to Sarah Dearman an orphan by Charles County Court Put under the Guardianship of the said William Bryan, until she arrives at the age of sixteen years. The Condition of the above Obligation is such that if the above bound William Bryan, James Dearman, and Thomas Coleman or either of them do & shall well and truly pay or cause to be paid to the said Sarah Dearman the said sum of sixteen Pounds Ten Shillings and six pence Current Money when the said Sarah Dearman arrives at the age of sixteen years then the above Obligation to be void Else to remain in full force Power and Virtue in Law
