Well Rememberd that John Muschell Pursuant to the Directions of the Act of Assembly

Charles County ff On the 18: day of March 1718 M: John Muschell made Oath on the Holy Evangelist
of Almighty God that the above account is just and true and that he hath not received any Part or Part or
any Security or satisfaction for the same, and has been credibly informed that the said Redham Trussell
is Run away These are to require you immediately on Sight hereof to give Attachment for
the Effects of said Redham Trussell, as well for the sum of Eleven Hundred and Fifty and Eight pounds of
Tobacco Debts as for the Costs which shall accrue thereon for the Use of the said John Muschell, Given under my
hand this 18: day of March 1718.

To the Clerk of Charles County

Whereupon It was Commanded the Sheriff that of the Lord's Chables and Credits of the said
Redham Trussell in spirit Bailynick being he should Attack as well the sum of Eleven Hundred and
Fifty Eight pounds of Tobacco Damages as Six Hundred pounds of Tobacco for Costs that had accrued and
that further should accrue in Prosecution of the Premises and when the same he had Attached or any Part
hereof that he should have it before the Justices of the Lord Proprietary of his Neat County Court to be
holden at Charles Town on the second Tuesday in June Next there and there to be condemned according to
Law
