 and there by himself or some full Attorney and come over unto the said John Muschell of a plea of
 Trespass upon the Case and that by Good and Lawfull men of his County which he should make
 known to the Person or Persons in whose hands he should make the same Attachment that he
 she or they be and appear before the Justices of the said Lord Proprietary at the Place and Time set to
 show Cause if any be she or they have why the Sum in their or any of their hands attached should not be
 Condemned according to Law and the said John Muschell have threat Execution of £ and how he should
 Execute that Writ that he should make known to the Justices aforesaid at the Time and Place aforesaid
 and that he should have then and there that Writ and the Names of those before whom he should make
 the same known &c. And now here at this day to wit the said Tuesday in June aforesaid comes the
 John Muschell by Jeremiah Chase his Attorney and offers himself against the said Rodham In the Plea aforesaid
 the Sheriff returns to the Court here the Writ aforesaid thus Indorsed Viz

 the within Writ some discried that on the first day of April 1719 I attached of the Effects of the within mentioned

 Costs within mentioned as of the Effects of the within mentioned Rodham Inpsell for the Use of the within
 mentioned John Muschell before John Ward and William Thompson and also I have made known to
 the above named that he be and appear before the Justices within mentioned at the Time and Place
 within prescribed to show Cause why the said Effects so attached in his hands should not be condemned
 according to Law before Good and Lawfull men of my County which as I am hereby commanded

 by the Court here that the said John Muschell have Condemnation of the Sum of one Thousand Pound of Tob^o
 so as in the schedule aforesaid attached by the Court here adjudged according to the form and Effect of the
 Act of Assembly in those Cases late made and provided and that the said John Muschell have Show of
 Execution of £
