Whereupon into Court here in his Proper Person Comes Justinian Burchell Charles County Planter and becomes pledge and Security for the said James that if it should happen that James in the Plaintiff should be convicted that then the said Justinian Yeilde and granted that tuncille the Defendant pay all Costs to which to heretofore Thomas & Company in this Part should be adjudged of his Lenes and Chattels should be made and levied to and for the use of the said Thomas & Company that if it should happen that the said James the debt damages & Costs aforesaid to the said Thomas & Company should not Pay his body into the Custody of the Sheriff by Reason whereof And then the said James by William Middleton his Attorney Comes and defends the same and Injury whereto and says that he cannot deny the action aforesaid of them the said Thomas & Company nor but that he did assume upon him self in manner and form as the said Thomas & Company against him hath Complained nor but that he owes to them the said Thomas & Company the sum of Five Thousand four Hundred and Thirty Eight Pounds of Tobacco as the said Thomas & Company above in ducaring supposed. Whereupon the said Thomas & Company by Jeremiah Chase their attorney aforesaid Pay Judgment and their Debts acknowledged together with their Costs and Charges by him about their Suit in this Part laid out and Expended to them to be Adjudged. Therefor it is Considered by the Court here that the said Thomas & Company do Recover against the said James their Debts aforesaid to Five Thousand four Hundred and Thirty Eight Pounds of Tobacco as also the sum of Two Hundred and forty six Pounds of Tobacco for their Damages Costs & Charges by him about their Suit in this Part laid out and Expended on their aforesaid by the Court here Adjudged Definited and the said James Pay on in Money aforesaid.

R. William Howard Judgment for Non Sum Dam. as specified of the Court according to Mr. Charles County vs. William Howard late of Charles County Planter was Attache to this man unto Matthew Gody of a plea of trespass upon the same and of forth

And Whereupon the same Matthew by Jeremiah Chase his Attorney complains that Whereas the said William the seventeenth day of February in the year of our Lord one thousand seven hundred and forty eight at Charles County aforesaid was Indebted to the said Matthew in the sum of one thousand five hundred and five pounds of Tobacco for divers Articles lying Properly in his Possession and by the particular account thereof herewith into Court brought may appear and being so there of Indebted thereto William in consideration thereof afterwards to wit the day and year aforesaid at the City aforesaid upon himself Abstained and to the said Matthew then and there faithfully Promised that he the said William the said sum of one thousand five hundred and five pounds of Tobacco to the said Matthew when thereunto afterwards he should be requested will and truly would Content and Pay.

NEVER THE LESS the said William his Promise and Assumption aforesaid not regarding but intending fraudulently Intending the same Matthew in this Part Craftily and Subtilly to deceive and defraud the said William the said sum of one thousand five hundred and five pounds of Tobacco or any Part thereof to the said Matthew hath not Paid nor him for the same in any sort Contented at this the said William afterwards to wit the first day of April in the year of our Lord one thousand seven hundred and forty nine and often afterwards at Charles County aforesaid by the same Matthew hath been Requested but the same to him hither to to Pay or him for the same in any sort to Content he hath either to to Pay or him for the same in any sort to Content he hath either to altogether refused and Will not Refuse to the Damage of the same Matthew Gody three thousand and ten pounds of Tobacco and therefore suit is brought and so forth.
