Note to the before mentioned William Skyrin and by the same Indowment or deed and appointed the afo. Joseph Edelen to pay to the same William Skyrin the afo. Sum of Eleven Hundred and Ninety five Pounds of Tobacco in the said Note specified according to the form and Effect of the same Note of which assignments the said Joseph Edelen afterwards to wit the day and year last mentioned at the County afo. had notice and by reason of the Premises also by force of the Statute in such Cases made and Provided the said Joseph Edelen became liable and Chargeable with the Payment of the Sum of Eleven Hundred and Ninety five Pounds of Tobacco according to the tenor of the said assignments afo. to the said William Skyrin and the same Joseph Edelen being so Chargeable in Consideration thereof afterwards to wit the day afo. last above at the County afo. assumed upon himself and to the same William Skyrin faithfully promised that he the afo. Joseph Edelen would well and truly pay and Content to the same William Skyrin the afo. Sum of Eleven Hundred and Ninety five Pounds of Tobacco when he should be thereunto afterwards Requested. Yet the said Joseph Edelen his Promise and Assumption afo. in form afo. made not in the least regarding but minding and fraudulently intending him the said William Skyrin in this Part craftily to deceive and defraud the said Sum of Eleven Hundred and Ninety five Pounds of Tobacco to the said William Skyrin hath not Paid or in any sort Contented, altho so to do the said Joseph Edelen was afterwards to wit on the first day of May In the year of our Lord One Thousand Seven Hundred and forty Nine and often before and since at the County afo. thereunto Requested but the same to the said William Skyrin to pay has Denied and still doth deny to the Damage of the said William Skyrin Two Thousand Three Hundred and Ninety Pounds of Tobacco and three pence six farthings and so forth

And the said Joseph by William Middleton his attorney comes and defends the force and Injury therein and says that he cannot deny the Assignments of the said William Skyrin but that he did assume upon himself in manner and form as the said William Skyrin above against him hath complained nor also but that the said William Skyrin hath sustained Damages by means afo. respecting the Promises and Assumptions afo. to Eleven Hundred and Ninety five Pounds of Tobacco as the said William Skyrin above in declaring supposes WHEREUPON the said William Skyrin by Jeremiah Chace his attorney afo. pray Judgment and those Damages to be acknowledged to be their due his Costs and Charges by him about his Suit in this Part laid out and Expended to him to be adjudged Therefore it is Considered by the Court here that the said William Skyrin do recover against the said Joseph Edelen his Damages afo. to Eleven Hundred and Ninety five Pounds of Tobacco afo. Acknowledged as also the sum of One Hundred and Ninety six Pounds and three Quarters of a pound of Tobacco for his Costs and Charges by him about his Suit in this Part laid out and Expended on his
