We do also present Benjamin King for a break of the peace on the body of Newman Amphion by Information of Charles Lord Constable. — *Hawkins foreman*

August 9<sup>th</sup> 1779. We the Grand Jury for the Body of Charles County do Present William Breeding for begetting a bastard Child on the body of Sarah Foley by Information of Sarah Foley. — *Hawkins foreman*  
We do also present John Clark for concealing his son Moses as a Fugitive by the Information of Thomas Matthews. — *Hawkins foreman*

We do also Present Ann McFarling for bearing a Mulatto Bastard on the Information of this Jury witness. — *Hawkins foreman*

We do also present Edward Smart for selling Liquor on his own Plantation Contrary to an Act of Assembly in such Cases made and Provided by Information of Nathan Harris. — *Hawkins foreman*

We do also Present Monica Braggott for bearing a Mulatto Bastard by Information of Captain William Drury. — *Hawkins foreman*

Whereupon they are discharged and Allocated four hundred Pounds of Tobacco.  
Ordered that Clerk issue Process on all Defendants found this Court. —

Proprietary to Grand Jury. —

Charles County vs. Memorandum: That this day came before me one of his Lordships Justices  
of the Peace for the County aforesaid Timothy McCar, Daniel McCane, and John Green and a Writ of Summons  
Each of them was to be Justified to the Right Honourable the Lord Proprietary in the full and just sum  
of Fifty pounds Current Money, and together with them came Michael Farrel their Surety, and  
Acknowlegde himself to owe and stand justly indebted to the said Lord Proprietary in the full and just  
sum of Fifty Pounds like money, to be used of their several Rodos, gardens, Chatel's Lands and  
Tenements to the use of said Lord Proprietary his Heirs and Successors On Condition, That  
Timothy McCar, Daniel McCane, John Green shall and do make their Personal appearance  
before the Justice of Charles County Court Next to be holden at Charles Town, Maryland there to  
Answer unto all such Matters or things as shall be laid to their Charge concerning a Ferry Boat  
brought thence from Andrew Monroe, and not depart the Court without leave, then this Recognizance to  
stand and none Effect, or Else to stand and remain in full force and Virtue on Law.

Signed and Acknowledged this 5<sup>th</sup> July 1779 before *P. Harrison*

And now here at this day to wit the second Saturday in August A.D. the Year of our Lord Timothy McCar,  
Daniel McCane and John Green according to the Tenor of the Recognizance aforesaid nothing material  
being against them alleged, they the said Timothy, Daniel and John together with their main  
Partner Michael Farrel from the force and Effect of the same Recognizance were Requit and Discharged  
paying the several fees arising due to the officers ministers of the Court here by Due course of the Revision.
