Railey of Charles County Planters and acknowledge themselves to owe and stand Justly indebted unto his Lordship the Right Honourable the Lord Proprietary in the sum of One Hundred Pounds Current Money each which sum they and each of them severally yealded and granted should and might be levied on their and each of their Goods and Chattels Lands and Tenements to hand for the use of his said Lordship his Heirs & Successors.
