

## August Court Anno Domini 1729.

Whereupon into Court here in his proper Person Comes the said John Butler of Charles County Planter and Acknowledged himself to One and Stand Justly Indebted unto his Lordship the Right Honourable the Lord Proprietary in the Sum of Thirty Pounds Current Money which Sum he yielded and Granted should and might be made and levied on his Goods and Chattels and Tenements for the use of his said Lordship his Heirs and Successors —  
**On Condition** that the said Elizabeth Butler do and shall make her Personal appearance before his Lordships Justices of Assize Next to be held at Charles Town on the Twenty Fifth day of September then Next to Testify for his said Lordship's Debt against Maccan, and not to depart the same Court then without Licence thereof —

Ordered by the justices of the Court here that John Butler recognize in the Sum of Thirty Pounds Current Money for his Wife Elizabeth Butlers appearance before his Lordships Justices of Assize Next to be held at Charles Town on the Twenty Fifth day of September then Next to Testify for his said Lordship against John Green.

But Remember'd that Daniel Maccan appears here according to the Tenor of a certain Recognizance taken here this Court together with Thomas Morris and John Hamill his main Sureties in the Sum of One Hundred Pounds Current Money each for the said Maccan's appearance here from day to day during the sitting of this Court. Therefore he the said Daniel together with his main Sureties are from the force and Effect of the same Recognizance acquitted and Discharged —

But Remember'd that John Green appears here according to the Tenor of a certain Recognizance taken here this Court together with Timothy Maccan's John Hamill his main Sureties in the Sum of One Hundred Pounds Current Money each for his the said Green's appearance here from day to day during the sitting of this Court. Therefore he the said Green together with his main Sureties are from the force and Effect of the same Recognizance acquitted and Discharged —
