But remember'd that heretofore to wit the second Tuesday in March last by the  
Oath of fifteen Jurors namely Peter Wood &c was Presented Catherine Boyne for bearing  
a bastard Child. And now here at this day to wit the second <sup>Tuesday</sup> August a<sup>s</sup>. the a<sup>s</sup>.  
Catherine in custody of the Sheriff namely Samuel Hanson Gent Coman to the Court here brought  
in his proper person Comes and being Demanded of her by the Court here whether she be Guilty of  
the Bastardy a<sup>s</sup>. above upon her Imposed she the said Catherine Boyne says she is that of Guilty  
in manner and form as by the Presentment a<sup>s</sup>. against her it is alleged. Therefore it is  
Considered that the said Catherine Boyne be sent or suffer Corporal Punishment according to the  
Directions of the act of assembly in those Cases let make and Provided, and for that the said Cath:  
Cannot Lay or Cause any Person to be Attorney for the fine a<sup>s</sup>. by the act a<sup>s</sup>. Imposed.  
It is ordered the Sheriff that he take her to the Whipping Post and having stripped her naked from the  
Waist upwards their give her Twelve Lashes on the Bare Back for her offence a<sup>s</sup>.  
And afterwards to wit the same second Tuesday in August a<sup>s</sup>. the Sheriff a<sup>s</sup>. Returns to the Court  
here that he hath done Execution of the said Judgment upon the a<sup>s</sup>. Catherine Boyne.  
Whereupon into Court here in his proper Person comes William Lloyd of Charles County  
Planter and becomes Pledge and Security for the a<sup>s</sup>. Catherine to pay the several fees arisen due to the  
Officers and Ministers of the Court here by occasion of the Premises.  
Whereupon it is by the Court here further Considered that the said Catherine Boyne do have her  
Master one year and a half Inconsideration of the loss of Time and Trouble of his House and the  
Fees arisen due to the Officers and Ministers of the Court here by occasion of the Premises.
