 the Court here that the said William do recover against the said Henry his Damages by Reason of the
 Premises and which by the Justice of the Court here are aforesaid to be fifteen pounds seven Shillings
 and six pence Current as also the sum of those Hundred and Eleven pounds and six Shillings
 for his Costs and Charges by him about this Suit for this part laid out and Expended to the use of
 Defendant of his spent by the Court here adjudged and the same Henry in May 1759

Henry Marten Judgment of Cognovit Action

Charles County s^r Henry Marten late of Charles County Planter was attached to an account of James
 Freeman Administratrix of all and Singular the Goods and Chattles Rights and Credits which were of
 James Freeman late of Charles County Inhabitant Deceased who Died Intestate as is said of
 a plea of Trespass upon the Case and so forth
 And whereupon the said James Freeman by Sumiah Chase her Attorney complains for that
 whereas the said Henry on the Twenty Sixth day of August in the year of our Lord one Thousand Seven
 Hundred and forty seven at Charles County aforesaid was indebted unto the said James Freeman in his
 Lifetime in the sum of fifteen Pounds Eleven Shillings and Eleven pence half penny Currency for divers
 Particulars lying Properly in an account as by the Particulars Account thereof herewith into Court brought may
 appear and the said Henry being so thereof indebted in consideration thereof afterwards to wit the same
 Twenty Sixth day of August in the year and at the County aforesaid upon himself assumed and to the same
 James Freeman in his Lifetime then and there faithfully promised that he the said Henry Marten
 the said sum of fifteen Pounds Eleven Shillings and Eleven pence half penny Currency to the said
 James Freeman in his lifetime would well and truly content and pay when the same afterwards he should
 be requested nevertheless the said Henry Marten his Immoveable and assumption aforesaid made
 notwithstanding the said Henry Marten being and fraudulently intending him the said James Freeman in
 this part craftily and subtly to deceive and defraud the said sum of fifteen Pounds Eleven Shillings
 and Eleven pence half penny Currency to him the said James in his Lifetime or to the said James Freeman
 Administratrix aforesaid after the death of the said James to whom Administration of all and Singular the
 Goods and Chattles Rights and Credits which were of the said James Freeman at the Time of his Death
 by Walter Hanson Gentleman Deputy Comptroler of the County aforesaid after the death of the said James
 Freeman in due form of Law was committed for to the same James Freeman Administratrix aforesaid Altho the
 same Henry Marten on the fifth day of December in the year of our Lord one Thousand Seven Hundred
 and forty seven and often afterwards at Charles County aforesaid by the said James Freeman in his life
 Time and by the said James Freeman Administratrix aforesaid after the death of the same James Freeman to wit on the first
 (Day)
