Beit Remembered that on this day to wit the Second Tuesday in November 1720 into Court here in his proper person Comes Timothy Maccan of Charles County Taylor according to the Tenor of a Certain Recognizance taken before the Justices of Assize Nisi prius Cyph and Terminus and Goal Delivery, that is to say the said Timothy Maccan In the sum of Fifty Pounds Current Money of Maryland together with the John Hamill & Bartholomew Anderson his main persons In the sum of Twenty five pounds like Money Each for his the said Timothy Maccan's appearance to answer &c. and not depart &c. Whereupon it was ordered that the same Recognizance be respitted and continued until the Next Court to be holden at Charles Town on the Second Tuesday in March Next &c.

Dennis Marten's Discharged

Beit Remembered that on this day to wit the Second Tuesday in November 1720 into Court here in his proper person Comes Dennis Marten of Charles County according to the Tenor of a Certain Recognizance taken before the Justices of Assize Nisi prius Cyph and Terminus and Goal Delivery, that is to say the said Dennis Marten In the sum of Fifty pounds Current Money of Maryland together with the John Hamill and Daniel Monroe his main persons In the sum of Twenty five pounds like Money Each for his the said Dennis Marten's appearance to answer &c. and not depart &c. Whereupon the same Dennis Marten together with his main persons aforesaid from the force and Effect of the same Recognizance are Acquitt and discharged

Ordered by the Justices of the Court here that Dennis Marten Assignee in the sum of Fifty Pounds Current Money of Maryland with Two Securitys in the sum of Twenty five Pounds like Money Each for his Good Behaviour to and appearance at the Next County Court to be holden at Charles Town on the Second Tuesday in March Next there to answer &c. Whereupon into Court here in his proper person Comes the said Dennis Marten of Charles County and Bartholomew Anderson and Thomas Bailey of some County Clarters and Acknowledge themselves to owe and stand Justly Indebted unto his Lordship the Right Honble the Lord Proprietary that is to say the said Dennis Marten in the sum of Fifty Pounds Current Money of Maryland and the said Bartholomew Anderson and Thomas Bailey in the sum of Twenty five pounds like Money Each which Sums they and Each of them severally Vcited and Granted should and might be levied on their and Each of their Goods and Chattels Lands and Tenements bound for the Use of his said Lordship his Heirs and Successors on Condition that the said Dennis Marten do and shall make his personal appearance at the Next County Court to be holden at Charles Town on the Second Tuesday in March Next there to answer unto all such Matters & things as shall be Objected against him on behalf of his Lordship the Lord Proprietary and stand to and abide by the Judgment of the said Court and in the mean time keep the peace and be of Good Behaviour to wards his said Lordship the Lord Proprietary and all other people of this Province and not depart the same Court without leave thereof
