

The Justices here pursuant to the Directions of the Act of Assembly in those Cases late made and Provided do describe the following main Roads and do appoint the several Persons Overseers of the same Roads for the Ensuing year according to the several Precincts and divisions following Viz^d

The Road from the Head of Portobauo Creek to Stones Mill and the Road which strikes out of said Road and Leads through Cedar Point Neck to Pissimmon Point, and the Road from Stones Mill into the Neck Road a^d. by the late John Cassons and the Road that strikes out of Nanjomy Road Near the Plantation of John Muschick and leads by Thomas Mitchells a Branch called the Huckle Berry Branch and also the Road that strikes out of the Road that leads from Portobauo to Nanjomy to the Worshipfull Mr Walter Hanson

Alexander McPherson Jun^r & Sam: Hanson's Overseers

The Road from Francis Crays to Mattawoman Road from the late Major Sam: Hanson's Quarter to the old Mattawoman Road to Wheelers Mill, the Road that strikes out of Mattawoman's old Road to the Huckle Berry Branch & also a Road from the late Colonel Hanson's Road by the Court's estate to Mr Maddox formerly lived to Daniel Boswens also from Mr: Ray: Smallwoods to Parkers Run, by John Davis's to Nanjomy Church — Edward Maddox & John Cole Overseers

The Road from the Head of Portobauo Creek to Mattawoman Swamp and from the Head of Portobauo to the main Run by Semmes and from the Late Major Sam: Hanson's into the main Road below Mr: Spink and the Road called Annapolis Road from ad Comfretts Race to the Road that leads from Port. to Wheelers Mill & the Road from Piscataway Road to Mattawoman Run by old Plankhills Giles Green Overseer

The Road from Piscataway Road below David Southlands Mill to Wheelers Mill and the Road called Annapolis Road from the a^d. Road to the Huckle Berry Branch and the Road that Leads to the Worshipfull Mr William Gilbecks Plantation and the Road from Wheelers Mill to the Head of Mattawoman Creek and also a Road beginning at the Head of Mattawoman Creek leading through the Worshipfull Mr William Gilbecks Plantation and from thence through the Woods to Peter Woods Indenture and through the Plantation & William Gilbeck Overseer

The Road from the Head of Portobauo to the old Court House and the Road that strikes out of the a^d. Road and leading to Henry Kerobin's and the Road from the Head of Portobauo Creek by Lidstone Smallwoods to Leach's Upper Bridges and the Road by Edward Jenkins's — Mr Madelon & Merina: Semmes Overseers

The Road from Portobauo Fresh by Semmes through Monmarinch to Mattawoman Swamp and also the East Road from Charles Irons Round Portobauo Hill and a Road from the Main Road under Shunk's to the Worshipfull Mr: Daniel & Thomas Senfers — Thomas Symson Overseer

The Road from Kings Creek to Allens Fresh Bridge from Allens Fresh Bridge to Piles's Bridge from Lambams Price House to the Mulberry Tree Landing to Piles's Fresh from Allens Fresh to the Late Vincent Ashins the Road that strikes out of the Road to Piles's Fresh and the Road that strikes out of the said Road to Newport from Leach's old Bridges by John Dents to John Gates also from the Easternmost End of the Widow Dents Plantation Near a path over the Swamp and from thence till it Interfer with a Road on the other side of said Swamp leading from the Cool Springs to Piles's Fresh to fall into the Road near John Davis's also a Road to be Cleaned from the Easternmost End of the Widow Dents Dwelling Plantation Near a path which now is over the said Swamp and from thence until it Interfer with a Road on the other side of said Swamp leading from the Cool Springs to Piles's Fresh to fall in to the said Road Near John Davis's Jo: Walter & Sam: Low: Overseers
