The Road from the head of Portobauo Creek to Richard Thompsons and the Road Near Mr. Jane Cortes Quarter to Chapple Point. — Nichl. Sherbon Overseer

The Road from Peoples Bridge to the old Court House to Town and the Road that Leads to Doctor Gustavus Browns House to Town and the Road from Doctor Browns to Colonel Dent and also the Road to Thompsons Landing. — Janatius Doyne Overseer

The Road from Pichawaen Church till it intersects the Road that Capt. Hoarman Goes — Anna Pearson Overseer

The Road from the Cool Spring Road by Joseph Johnsons to Benedict Town from Richard Standfords to Benedict Town from the Road by the late Randolph Morris to Indian Creek Bridge from John Estep the Road that Leads by John Andersons from the Upper Bridge Swansons Creek and the Road that leads by Captain Smiths to Benedict Town from Swansons Creek Landing by the Widow Lyons to the Road from the New Bridges from J. Johnsons to the manner Branch from Joseph Johnsons to M. Wilkinsons Mill from George Wallots the manner Branch also from the Head Swansons Creek to Wilkinsons Landing the Cool Spring Road from a place called the Three Cheonuts to the Widow Standfords and the usual Rolling Road from G. Ladings Rolling House to Browns Landing and also to a point in Washing the ridge over M. Wilkinsons Mill Branch. — J. Moran & Law. Church Overseers

The Road from the Manner Branch to the Upper Borders of the County from the Upper Bridge Swansons Creek to Paul Howling's Run from a place called the Three Cheonuts to Lees Quarter also the Road which formerly led from James Nators by the Widow Howells till it intersects the Coach Road. — John Thomas Junr Overseer

The Road leading from Benjamin Gwinns North Line down the bottom of Cob's Neck — John Wilder Junr Overseer

The Road from Richard Thompsons to Pichawaen Church that makes out of that to Thompsons Ferry and also the Road to Jones's Ferry from Philpotts Gate a Cross Pichawaen's main Road to Jones's Ferry and the Road that strikes out of Pichawaen's main Road to Lees Ferry and the Ferry Road by the late Captain Howards to Pichawaen Church also from Jones's Ferry the nearest and best way to Philip Jenkins's and the old Road that goes by the Widow Howards into the main Road to Portobauo also a Road to be cleared to Lower Cedar Point to begin at the main Road that Leads from Pichawaen Church Near Cody's Gate thence through a Lane between the said Cody and Joseph Gwinns from thence through Captain Benjamin Douglafs Plantation now in Possession of his Son John Douglafs and thence by Philip Jenkins's to Cedar Point also out of the main Road between the Dwelling House of the late Colonel J. Sordell & M. Richard Marshalls from thence leading over the High Lands until it meets the old main Road at the Lower Side of the Late Major Gates's Plantation & also the Road leading from Richard Smiths to Cedar Point Wave Head. — Philip Jenkins Overseer

The Road from Piles Fresh to Benedict Creek from Piles Fresh up the Swamp by Oliver Wrenches to the Extent of the County and the Road that strikes out of the Road from Piles Fresh to Benedict Creek towards all parts Church to the Borders of the County — Joseph Pile Overseer
