Be it Remembered that Pursuant to an Order of Court taken at Charles Town on the Sunday in June last Commission Issued Returnable here to Examine Witnesses touching the Bounds of a Tract of Land Called Frogg Nest lying in the said County in the Following Words to wit -

Charles County sh. Charles Absolute Lord and Proprietary of the Province of Maryland and Avalon Lord Baron of Baltimore sh. To Richard Harrison Joseph Harrison Harrison Robert Calvert and John Stranmatt Gentlemen Whereas Clement Henry Esq. a Surveyor of a Tract of Land Called Frogg Nest lying in the said County did on the Twentieth day of June being in the Thirtieth Fifth year of our Dominion sh. Present his certain Petition in Writing to our Court, that is to say our County Court held at Charles Town in and for the said County on the day afo. before Gust. Brown Gentlemen and his Associates then and still our Justices within our County sh. for Commission to Examine Witnesses to Prove and Perpetuate the Memory of the Bounds of the said Tract of Land according to the Directions of the act of Assembly lately made and Revised sh. that we have given you any three or two of you not being any way related to the Petitioner Contiguous Proprietor nor Interested in the said Land and having taken the Oath Prescribed by the above named act of Assembly full Power and Authority to Examine upon their Oath to be taken by you any three or two of you Administered all the Oaths which shall be Nominated to you any three or two of you by the above named Petitioner or other Person concerned touching their Knowledge of the Bounds of the Tract of Land described in the Bounds of any other Land whereon the aforesaid Tract Depends or whoso it Relates and therefore Command you any three or two of you that you Call and Cause to be before you any three or two of you all the Witnesses Nominated at a certain day by you any three or two of you to be appointed upon the above mentioned Tract of Land and the Examination of every Witness so called before you that you any three or two of you Carefully Pledge into Writing in the Presence of all Parties concerned that shall be there Present and the Examination so taken as aforesaid you any three or two of you are to Return to the Justices of our Court with all convenient Speed Under your Seals or the Seals of any three or two of you together with this Writ Provided always that all Parties concerned Living within or without the County sh. have Notice according to the Directions of the act of Assembly before mentioned of the Day and Place of the Execution of this our Commission before the Execution thereof and that you any three or two of you and to Return to our Justices aforesaid with all convenient Speed a Certificate of such
