Therefore it is Considered that the said William Penn be fined the sum of One Shilling Current Money for the offence afo. by the Court here Adjudged and the said William be taken &c. Whereupon into Court here in his proper person Comes Godshall Barnes of Charles County Planter and becomes Pledge and Security for the aforesaid William Penn to pay the fine aforesaid and also the several fees Arisen due to the Officers and Ministers of the Court here by Occasion of the Premises. Sarah Goley's Conviction & Confession

But Remember'd that on this day to wit the second Tuesday in November afo. Sarah Goley in Court here in her proper person Comes according to the Tenor of a certain Recognizance taken here on the second Tuesday in August last for her the said Sarah's appearance here &c. Whereupon Henry Darnall Esq. his Lordships Attorney General Cretenus Gives the Court here to Understand and be Informed that the said Sarah Goley was and still is Guilty of bearing a bastard Child and prays the Advice of the Court therein. Whereupon the said Sarah presents here in Court as afo. being Asked whether she be Guilty of the Premises afo. on her Imposed, saith she is thereof Guilty in manner and form as against her it is Alleged. Therefore it is Considered it is Considered that the said Sarah Goley be fined on suffer Corporal Punishment, according to the Discretions of the Act of Assembly in those Cases late made and Provided, and for that the said Sarah cannot pay or procure any person to be Security for the fine afo. by the Act aforesaid Imposed. It is ordered the Sheriff that he take her to the Whipping Post and having Stripped her naked from the Waist upwards their Gize her Twelve Lashes on the Bare Back for her offence aforesaid. And afterwards to wit the same second Tuesday in Nov. afo. the Sheriff aforesaid Returns to the Court here that he hath done Execution of this said Judgment upon the said Sarah. Whereupon into Court here in his proper person Comes Isaac Sims of Charles Co. Planter and becomes pledge and security for the said Sarah Goley to pay the several fees Arisen due to the Officers and Ministers of the Court here by Occasion of the Premises
