Charles Courts of Charles County Planter otherwise called Charles Courts was summoned to answer unto Hugh Mitchell his Heirs or assigns of paper that he render unto him the just sum of seven hundred & twenty five pounds Crop Tobacco which to him he owes and unjustly detains and so forth. And the said Charles in his proper person comes and defends the force and injury whereunto he is bound and says that he cannot deny the action a<sup>s</sup> of him the said Hugh nor but that he owes to the said Hugh the said sum of seven hundred & twenty five pounds of Crop Tobacco in manner and form as the said Hugh above a gainst him complains. Therefore it is considered by the Court here that the said Charles do owe or a gainst the said Hugh his debt a<sup>s</sup> and his damages by occasion of detaining that debt to one hundred & fifty pounds & three quarters of a pound of Tobacco to the said Hugh on his a<sup>s</sup> by the Court here adjudged thus Charles in May 1729
