Comensend defends the force & Injury when &c. and the same Attorney says that he is not informed of any Answer to the said Samuel Hanson for the said Jeremiah Aderton in the plea aforesaid to be given and nothing other thereof does he say whereby the same Sam. Remains against the said Jeremiah Aderton thereupon without defence. It is therefore Considered by the Court here that the said Samuel Hanson do Recover against the said Jeremiah Aderton his Damages by Occasion of the Premises & that by the Justice of the Court here are aforesaid Two Thousand Three Hundred & Eighteen p^{cs} of Tobacco & Nine Shillings & Two Pence Current Money Seventeen Hundred & twenty seven pounds of Tobacco Spanish paid in Inspected Tobacco be liable to deduction of one fourth according to Act of Assembly & also Four Hundred & thirty Three pounds and one Quarter of a pound of Inspected Tobacco for his Costs and Charges by him about his Suit in this part laid out and Expended to the said Samuel of his Agent by the Court here Adjudged and the said Defⁿ in the said Jeremiah Aderton in May 1729

John Walker. Judgment of Cognovit Actionem

Charles County sh. John Walker late of Charles County Planter was attached to answer unto Mess^{rs} Tubman & Hartley of a plea of Trespass upon the Case &c. aforesaid. And whereupon the same Mess^{rs} Tubman & Hartley by Jeremiah Chase their Attorney Complain that whereas the said John Walker after the first day of May in the year of our Lord one Thousand Seven Hundred & five & four on the fourteenth day of June in the year of our Lord one Thousand Seven Hundred & forty eight at Charles County aforesaid did make his certain Note in Writing called a promissory Note with his proper hand and Name there to subscribed bearing date the same day and year last mentioned and the said Note unto the said Mess^{rs} Tubman & Hartley at Charles County aforesaid did deliver by which said Note the said John Walker Promised to pay unto Mess^{rs} Tubman & Hartley as their attorney the Costs of an Action at Law brought against one by James Newson their Attorney and also the Sum of sixteen Hundred & twenty five pounds of Tobacco being the balance due them for which said Action was brought by Virtue whereof and also by force of the Statute the said John Walker became liable & Chargeable to pay unto the said Mess^{rs} Tubman and Hartley the said Sum of sixteen Hundred & twenty five pounds of Tobacco and the said Mess^{rs} Tubman & Hartley in full say that the said Sum full Cost amounts to the Sum of Three Hundred & fifteen pounds of Tobacco and to the Sum of the Note aforesaid and being Chargeable the said John Walker afterwards toward the day & year last mentioned at the County aforesaid upon himself & promised and to the said Mess^{rs} Tubman & Hartley then & there faithfully Promised that he the said John Walker the said Sum of nineteen Hundred & forty pounds of Tobacco to the said Mess^{rs} Tubman & Hartley when they unto afterwards he should be requested will & truly would Content and pay. **NEVER THELESS** the said John Walker his promise & Assumption aforesaid not in the least regarding put minding and pretending the same Mess^{rs} Tubman & Hartley the said Sum of nineteen Hundred and forty pounds of Tobacco or any part thereof to the same Mess^{rs} Tubman & Hartley have not paid altho so to do the said John Walker was on the tenth day of June in the year of our Lord one Thousand Seven Hundred & forty nine and often since at Charles County aforesaid to pay the same but that unto them hitherto to pay or Content the said John Walker hath hitherto altogether Refused & still doth Refuse to pay the same to the damage of them the same Mess^{rs} Tubman & Hartley Two Thousand Eight Hundred & Eighty pounds of Tobacco and therefore Suit is brought the forth.
