- MARKLEY**, Christopher late of Annapolis, dec.; Jacob Falconer of Kent Co. and Francis Fairbrother, execs. and admins. (MG, 8 Aug. 1776)
- MARKIN**, Samuel gives notice his wife Elizabeth has absconded from his bed and board. (DMG, 14 April 1778)
- MARSHAL**, James late of Baltimore Town, dec.; John Brown, currier, and George Matthews, execs. (BMG, 8 Oct. 1784)
- MARTIN**, James will not pay debts of wife Elizabeth. (MJ, 31 Aug. 1779)
- MARTIN, Luther, Esq.**, Attorney-General of this State, and Maria Cresap, daughter of the late Michael Cresap of Washington Co. were married 25 Dec. last. (BMG, 16 Jan. 1784)
- MASON**, Abraham late of Philadelphia and Miss Sally Hayes of this town, were married. (MJ, 24 Sept. 1782)
- MASTERS**, William late of Prince Georges Co., dec.; Triphenia North, extx. (MJ, 6 April 1779)
- MATHER**, Elizabeth late of Baltimore Co., dec.; James Rice, admin. (MJ, 25 March 1777)
- MATHER**, John late of Baltimore Co., dec.; James Rice, admin. (MJ, 25 March 1777)
- MATTHEWS**, George died 18 inst. from a wound received by the bursting of a cannon. (Lines on his death). (DMG, 26 March 1776) dec. resided at Kingsbury Furnace, Baltimore Co. T. Russell and James Smith, execs. (MG, 25 April 1776)
- MATTHEWS**, Levan, dec.; Mary Matthews, adminx. (DMG, 8 Sept. 1778)
- MATTHEWS**, Richard late of Baltimore Co., dec.; Joseph Tetleay, admin. (BMG, 8 April 1775)
- MATHEY**, Frederick his wife Mary eloped from him on Tuesday 10th inst. (DMG, 15 Dec. 1778)
- MATTS**, Nicholas late of Baltimore, dec.; Conrad Reily, admin. (MJ, 10 Sept. 1784)
- MAWE**, James late of Annapolis, dec.; Thomas and Judith Doyle, admins. (MG, 30 Oct. 1777). Deceased was a carpenter. (MG, 9 July 1779). Judith Doyle, the widow and adminx. has given power of attorney to John Crisall. (MG, 1 Jan. 1784)
- MAXWELL**, George late of Charles Co., dec.; Elizabeth Maxwell, Charles Grahame, Robert Couden and James Campbell, execs. (MJ, 24 March 1778)
- MAXWELL**, George, dec.; Elizabeth Maxwell, the widow intends to petition the General Assembly. (MG, 28 Aug. 1783)
