Death of Jerome Bonaparte.

We are sorry to announce the death of our esteemed friend, Jerome Bonaparte, who died at his residence, 55 Park street, yesterday morning at 2 o'clock. Mr. Bonaparte was well known to many of the people of Baltimore, and was a man of great personal interest.

For some months past he had been confined to his residence by disease of the throat.

The doctor who attended him gave him every relief.

About two months since he was informed by his physicians that his recovery was impossible, and had to give up all hope of recovery.

He was then sent to Paris to see him.

He left France a few weeks back, took passage for New York, and came here on Monday evening.

He was a sick and somewhat expatriate. Miserable had he left his house. Since then he had been weak, but the news of the death sent to "The American" did not reach him until the eve of his arrival.

He was then sent home, but had been out several days beyond her regular time.

The deceased, Jerome Napoleon Bonaparte, was the son of the Emperor Napoleon and Miss Elizabeth Patterson, of Baltimore, who were married in this city by Bishop Carroll in 1803, and died in 1812, leaving him a widow at the age of twenty-four years. His mother by Napoleon and his husband is still living in France, where she has been confined to her bed for some time past, and is unable to leave her house.

Mrs. Bonaparte's health has been failing.

She has always been an excellent character.

Her son, Jerome, was born in 1806.

He was a man of very large fortune.
