I, Charles J. Remaparte, of Baltimore County  
in the State of Maryland, being of sound and  
disposing mind, memory and understanding, do  
make and publish this, my last will and testa-  
ment, in manner and form following, that is to say:

First. I give and bequeath to Cleveland P. Manning  
the sum of three thousand dollars, to Sarah G. Haydock  
the sum of two thousand five hundred dollars, to Hattie  
Gries the sum of one thousand five hundred dollars, to  
Emily W. Orhigen the sum of five hundred dollars  
and to Laura A. Slater the sum of two thousand dollars,  
provided that, in each case, the beneficiary shall be  
living and (with the exception of the one last-named)  
shall be still in my employ at the time of my death:  
these legacies to be payable in the discretion of my  
executors hereinafter named at any time within  
three years from my death, but to bear interest at  
(the)

The rate of five per centum annually from six months after my death until paid, and any legacy or succession tax thereon to be paid out of the residue of my property and estate.

Second. All the rest, residue and remainder of my property and estate, whether real or personal and wherever situated, including any whereof I may be authorized to dispose by virtue of any power of testamentary disposition, I give, devise and bequeath absolutely and forever to my wife, Ellen C. Bonaparte, such devise of the realty being in fee simple to her, her heirs and assigns or to the full extent of my own interest, estate or power of disposition therein.

Third. It is my desire that my said wife shall use and, if need be, exhaust the Corpus, no less than the income of my property and estate, as aforesaid given, devised and bequeathed unto her, to assure her own comfort and well being during the remainder of her life. Of, however, any portion or  
(part)

part thereof shall remain at the time of her death, they  
witho<sup>ut</sup> it in anywise hereby qualifying her absolute  
ownership and power of disposition thereof. I express  
the desire that she shall so dispose of the same by  
last will and testament to such of the children or  
direct lineal descendants of my late brother, Jerome  
Napoleon Bonaparte, as she may deem worthy to  
share therein, as will, in her best judgment, most  
certainly assure the well being of the children or  
descendants thus selected by her; this clause of my  
last will and testament being intended only as a  
suggestion for her guidance.

Fourth. I hereby appoint my said wife, Ellen  
C. Bonaparte, sole executrix of this, my last will  
and testament, and request that no bond be  
required of her as such.


Fifth. I hereby revoke all and all manner of wills
