The prober specifies that one officer shall be detailed for day duty and another for night the hours of such service to be fixed by the Chief of Police of the district. and whether any repairs are needed to provide additional safety to prisoners. This committee is composed of President Smith and Commissioners Brown and Pettebone. It is expected that they will make the inspection of the lockup within a few days.

THE TOTARY MISSELL STATES TO A COLUMN A new ferry scow, with motorpower, is to be provided for the Riverview Ferry at South River, the Board having approved of the recommendations of the commission recently appointed to ascertain the cost of same. This commission recommended the award of contract for the construction work to Frank Adams, at his bid of \$250. The county is to furnish all material for the scow and the estimated cost of the lumber, paint, oils and other necessaries is \$285, making a total of \$535. The commission says this will produce the cheapest and best scow to be had. The commission also inquired into the question of a gasoline engine for the ferry, and the firm of Parlett and Parlett, of this city, agreed to install an 8-horsepower gasoline engine for \$180. The commission also recommended the acceptance of this offer, and that the material be ordered by the County Engineer at once.
