men of hers sold by me for her to wit. Negroe Daniel sold to Miss
Vincendiere for two hundred and fifty dollars and Negroe William
a Blacksmith sold to Major Good of Washington County for three
hundred and fifty dollars have given granted bargained & sold
and by these presents do give grant bargain and sell unto the said
Eliza Lee the negroes herein after mentioned living on my
farm Needwood in Frederick County to wit one Negroe man
slave named Robert aged about thirty years and a Negroe
woman slave named Joan aged about twenty five years
and her two children named Dick and Betsy to have and
to hold the said Negroes herein before named Robert, Joan
Dick and Betsy to her the said Eliza Lee her executors admini-
-strators and assigns to the only proper use and behoof of the
said Eliza Lee her executors administrators and assigns for
-ever and to or for no other use intent or purpose whatsoever
In witness whereof I have hereunto subscribed my name
and affixed my seal this twenty second day of October
eighteen hundred and six
