To the Inhabitants of the Town of

GENTLEMEN,

THE present State of things in America, and this Province, calls for serious Attention. We are deeply interested in the present important Period; and since we are in one Common Cause, let us be united amongst ourselves. It is with respect to the Decrease of mutual Confidence amongst the Inhabitants of this Province, who were a few Months past, by the pleasing Ties of Love, now totally estranged from each other. A happy Situation has led us to suspect the Innocent, only because of some Circumstances to differ from our Opinions. Our Opinions may be to be Part of our Constitution, and a natural Firmness and Integrity, and more daring Methods for our Purposes; and from their fear, will unavoidably adopt some measures, which will not obtain the Approbation of a naturally timid and irresolute People. We may be true Friends to their Country, tho' by different Means, be out the same laudable Designs. We could sometimes divert ourselves (which to speak plainly, are not in narrow Minds) might be a most happy Medium. Let me be kind to you, my fellow Citizens, let us ourselves together, and dispassionately consider the Good of your Country; throw away when once indulged, will be cured by Circumstances in themselves. Our Country has with us nearly misrepresented to the British Parliament. May those who have form, and obtain Forgiveness.

Our Business is to take a View of our Situation, and to apply the best Remedy to our Disorders. We are at present engaged in Great-Britain, which annually sends us at least One Third more of Silver than we are able by our utmost Efforts to purchase in the present circumstances of our Country, in the present circumstances of our Commerce with other Places. The more we hear have thought fit to furnish with an additional Tax upon the Goods which we import from the Mother Country, plain, that the most tame Subscriptions can never answer the Expence of the Parliament, namely, to raise a Tax on the Toil and Industry, to support the Expence of the People, in Affluence. The Balance being so greatly in our Debt, cannot possibly be of long continuance, and of long continuance, without a constant draining of our Money, which is the Source of new Supplies, will lead us to a State of Bankruptcy: And we believe, that all knowing Men will, in this Situation, as well as from Humanity, refuse Appointments upon any other Terms; Nay further, I am encouraged to faithfully represent to their Excellencies certain pernicious Consequences. Sure I am, that they will seize this Opportunity of doing Justice to the Mother Country, and themselves to the distressed Inhabitants.

I cannot avoid taking Notice at this declining State, even of those few Goods in which our Labourers were employed; particularly the Ship-builders, who have been greatly injured of late, by the Expence of Lumber; this Trade, the Consequences of this Folly. Hungry and fully employed, are now deprived of obtaining a Support by honest Industry, before exposed to those Vices, which are the Attendants of Idleness and the Expence of English Refined Sugar, which has discouraged the manufacture of this Country.—I might instance in many other Manufactures, which we are now carrying out of our own Hands; and which, by some temporary Advantages, are concerned in these ruinous Excessive Importations, yet as we are in a general Decay of Business, and a general Decay of Industry, I would therefore request that we immediately come into a D
