

"Let them alone, George, printers, you know, are no Game for you."

May 8. A discovery of great consequence is just made in the physical world, which is, that antimony is a sovereign remedy in fevers, in warm climates particularly, and recovered several men on board the Juno, Capt. Storr, in her voyage to Falkland's islands, after the usual methods were used in vain.

May 9. It is said that Zell will be only a temporary retreat for the Queen of Denmark; as it is resolved that she shall return to England when matters have somewhat subsided.

May 10. Notwithstanding all the preparations at Zell, for the reception of her Danish Majesty, we have received a letter from Copenhagen, of very good authority, dated the 5th instant, which assures us, that the Queen Matilda is so insurmountable, that she has absolutely and finally declared, she will upon no consideration whatever be separated from the King; and that she persists in protesting against the consistorial decree of April the 6th, by which she was sentenced to be divorced from her royal consort, she still resolutely insists and persists, that she is either guilty or innocent; if the former, then she demands the same punishment that has been inflicted upon struensee and Brandt; if the latter, then she demands, as a matter of right, an ample restitution of her honour and royal dignity. This resolution has greatly embarrassed the Court of Copenhagen, and the result of it remains as yet a mystery of state.

May 12. Major Rogers, who was so serviceable in the command of a body of irregulars last war in America, has just obtained a commission from his Majesty for finding out the north-west passage in that quarter. He is to be allowed 31. a day for himself, and four shillings each for fifty companions of his own choosing. From the intimate acquaintance this gentleman has with the country, his knowledge of the Indian language, and, above all, having the object much at heart, the scheme seems to preface a very successful issue.

May 16. On Thursday the House of Commons agreed to the following resolutions, viz.

That, after the expiration of the present drawback of the duties of the customs upon tea exported to Ireland and the British plantations, a drawback be allowed of three-fifths parts of the duties of customs payable upon the importation of such teas, for a limited time.

May 19. Advice is received from Sir Robert Murray Keith, that the Court of Denmark are plotting something more against the Queen, in order to take her off; but that he apprehends, before they proceed any further against her, some other persons, who are well wishers to her, will be cut off; it having been noticed to the publick, that there will be more executions in a short time.

Orders are given for a fleet of ships to be ready to sail at a few hours notice; their destination is not known, but it is imagined they are bound up the Baltic.

Letters from the north of Ireland advise, that the insurrections of the populace are entirely quelled, and that many of the insurgents, who were chiefly composed of farmers and weavers, are preparing to embark for America.

#### BOSTON, July 9.

Two English seamen arrived last week in a vessel at Nantucket from the Havana, where we learn they have been imprisoned six or seven years. One of them came to town this week, and informs, that he was taken on the Spanish Main, and carried prisoner to the Havana, for being concerned in an illicit trade (as it is phrased by those who do not chuse to resent the behaviour of the Do's). During his imprisonment he suffered many hardships, and at length, growing old and infirm, was released. He says, there were forty-six stout able-bodied English seamen imprisoned at the Havana when he left it.

#### PHILADELPHIA, July 20.

By a gentleman who came passenger with Capt. Peel, from Lisbon, we have advice, that the ship Polly, Capt. Carmichael, from London for Maryland, having sprung leak at sea, put into Lisbon in great distress; she had five feet water in her hold, and all the pumps choaked with the ballast. It is imagined she will be detained some time to repair.

#### ANNAPOLIS, JULY 30.

The Publick may be assured that the Small-Pox has not spread, not a single Person having taken the Infection, except those who were confined to the House of Correction for their Reception, which is near 100 Yards distant from any other Dwelling House, and as the Guard is still continued, there is the greatest Reason to believe that the Town will be clear of it by the ensuing August Court.

#### TO THE PRINTER.

It is said to be the opinion of some of our lawyers, that the act for the establishment of religious worship in this province, made in the year 1702-3, is, for some reason or other, absolutely null and void. Now, I find that this act repeals the act of 1700, entitled, An Act for the Service of Almighty God, &c. But can a law be repealed by a writing, which is a meer dead letter? Can the act of 1702-3, void *ab initio*, repeal the act of 1700?—May it not, then, be a question, whether, upon a supposition of the nullity of the act of 1702-3, the act of 1700 is not now in full force?

What is the act of 1700? Does it not impose the payment of 40 per poll on the people?—Does it give less power to the clergy; is it less oppressive to the people?—Does it breathe a more benign and charitable spirit on Dissenters?—It is to be hoped, that those, who have an opportunity, will oblige the publick with a copy of this act in the Gazette; that we may be able to determine whether it will be worth our pains to destroy an old establishment, if we must be subject to another, perhaps not less exceptionable. And may we not expect from our lawyers, such of them especially as are our representatives, a full, frank, and explicit declaration of their sentiments upon both these acts? Surely, they will not, any longer, suffer the people to be bewildered in doubt and perplexity; when it is in their power to give light to their steps, and direct them to the right road.

Tell us not of the policy of suppressing opinions. That policy is nothing but trick and artifice, which would shut out truth from the eyes of a people in matters of important concern to them—of a people especially, who wish to pursue it; and desire nothing more ardently than to be informed how to conduct themselves with justice and propriety.—Here, however, I must enter my caveat against *baranguing*, as the proper mode of conveying instruction. It is, at best, too partial a communication for an object of universal concern.—But, in the hands of *men of art*, it is too apt to palm upon us chicanery for argument; and, instead of advancing truth, is a powerful instrument of amusement and delusion; more especially, if we consider who make up the bulk of hearers upon these occasions.—No, let us have it in plain black and white; that we may weigh it with deliberation, exercise our judgments coolly upon it, and form our best conclusions upon the genuine merits of the question.
